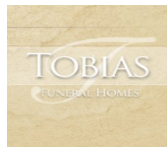

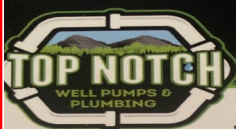

ROLL CALL – Niki: All council members present with the exception of Mark Warner and Judy Bruno.

PAST MEETING MINUTES – (Revisions or changes? Accept into record.) Spelling corrections include Tonina Laman-na, and Elaine Long. Katie Swiger also clarifies that the FOTO (Future of the Order) applications are out and folks will be notified in January (not July) if they are accepted.

UD Scholarship winner Joey Mullenix. Joey is here tonight and shared a little about himself. Joey is studying Engineering at UD and he grew up in Miamisburg Ohio. Joey shared some of his Italian traditions growing up, highlighting the importance of family.

COMMUNICATIONS – Niki: None

MEMBERS SERVICE AWARDS – Dan Bruno read allowed the names of all lodge members who are receiving 20-year certificates and 25-year pins. Those in attendance tonight stood for recognition. Congratulations everyone on your continued commitment to our lodge!

FINANCIAL SECRETARY REPORT – Frank Clement shared our current census is 509 members. Frank then shared information about 8 new applicants. Lisa and Scott Scherbauer, Debra Leister (national member), Thomas Varney (Marisa Varney's spouse), Jacqueline and James Oullette- oncologist (Andre Tagliamonte is sponsoring), Donald Achs (applied at Festa- Frank is sponsoring), and Anthony DelGhingaro. Discussion and questions. All new applicants were voted in together by membership by a unanimous vote. This brings our total to 517! Lastly, Frank highlights that the lodge gained 45 new members this year!

TREASURER'S REPORT: Due to guests being escorted out, Charlie reviewed report for both John Pirelli (JP) and Societa. Charlie shared details about all account expenditures and balances. Motion to accept report by Fred Ferrara/ Seconded by Steve Fleury. Discussion: None Voted Yes into record unanimously.

Also, during this report, Charlie gave a brief background, explaining that John Pirelli and Societa are 2 separate organizations, each having their own responsibilities. Societa owns the property and buildings, and John Pirelli uses these facilities and pays a fee to Societa annually per an agreement between the two. The agreement shares that JP will pay a standard amount annually to Societa, however this amount can be adjusted as needed, depending on the success (or lack thereof) of Festa. Motion made by Charlie Rigano for John Pirelli to pay Societa \$50,000 this year, for building/ grounds fees this year. Seconded by Erica Sigler- Discussion –Andre Tagliamonte asks what would the balance in JP account be? Andre asked if there is any benefit to having that much money in JP? Jack shared we have looked at this and this is as healthy as it's every been, and it's better to have more money on the Societa side. Charlie reminds this has already been discussed and passed via council. Jack adds that Societa money stays w/ us, whereas JP money would go to the state if we dissolved. Andre asked if we could pay this more than once a year/ different times throughout the year? Jack shared that we can be flexible at the time. We can change in future to semi – annual if needed.

Steve Carusone asked to explain why we can only have so much money in JP. Accountants say we should have below a particular threshold. VOTED: YES Unanimously.

MEMBERSHIP REPORT – Dan- none

STATE UPDATE – Gloria shared that the state meeting has not occurred yet. They are having the quarterly meeting on January 25th via zoom and a special meeting on January 11th for a bylaws change via zoom as well.

Len's Basic Spaghetti with Clam Sauce for Two

Ingredients:

Thin Spaghetti OR Linguini - about 6 ounces or as your preference
2 Tablespoons Olive Oil
1 can (6.5 oz) of Chopped Clams
2 Cloves of Garlic - minced
Fresh parsley - 1 Tablespoon - chopped
Salt and Pepper to taste



Process:

1. Boil water for pasta - add a bit of salt to water.
2. Sauté garlic in olive oil in a medium sauté pan until the edges just start to lightly brown.
3. Add juice from can of clams and heat over medium heat to simmer (Do Not Boil), then add the clams.
4. Add the chopped parsley and stir mixture for about 6 or 7 minutes.-Add black pepper to taste.
5. Drain the spaghetti, then return to the pot, add the clam sauce and toss until all pasta is coated.

UPCOMING ELECTIONS

As you may know elections for council will take place at the March, 2025 membership meeting. Nominations for this election will take place at the membership meeting in February. The nomination committee is now forming. If you are interested in serving on the nomination/election committees or would like to be nominated or nominate someone for office, call Fred Ferrara at 937-607-1527 or Anne Beecroft at 937-829-7716. The following lists the offices to be elected and describes the duties and responsibilities of each office of the council.

Duties and Responsibilities for the Offices of John Pirelli Lodge # 1633 and Societa DiMutuo Soccorso Italiana of Dayton, Ohio

President

The Lodge President is the highest ranking officer of the lodge. The President presides at all membership and Council meetings. The President appoints committees not otherwise provided for, and is an ex-officio member of all committees; further the President enforces the laws of the Order and carries out the deliberations of the assembly and the lodge council. By these expressed powers and duties, the President is the chief executive officer of the local lodge. The president answers inquiries from the general public and members and promotes the interest of the lodge by attending outside functions.

The Lodge President interprets the laws of the Order (excluding Judicial Code). Although the President may consider an opinion or interpretation by the Orator, the president's ruling is superior to the Orator's. The President signs checks with the counter signature of the Treasurer. The President votes at meetings only in case of a tie and participates in discussion only to clarify the issues.

The President is automatically a State Fraternal Delegate by virtue of his office.

Vice President

The Vice President is the second highest ranking officer of the Lodge. In the absence of the President at any meetings of the membership or Council, the Vice President acts in the place of the President. While acting as President, the Vice President assumes the same powers, duties and responsibilities. The Vice President also performs other duties as requested by the President.

Orator

The Orator ascertains that the laws of the Order are observed and properly applied. The Orator renders opinions on interpretations of the laws, except the Judicial Code, but his opinion is subordinate to the President's; he preserves order at all meetings. Upon the Orator's own initiative or when a complaint is made to the Orator, he has the power to file complaints against the member who violates the laws of the Order.

Recording Secretary

The Recording Secretary records and maintains the minutes of all membership and Council meetings. The Recording Secretary prepares the membership list, mails out the notices of membership meetings, prepares and mails the monthly newsletters to the members, reads the correspondence at the meetings, answers correspondence upon proper instructions, and also serves as the Clerk of the Arbitration Commission.

Financial Secretary

The Financial Secretary maintains the existing individual record of membership for each member. For new members, establishes membership record, records initial payment of dues and registration fee, issues "Billfold ID" as members of Sons of Italy and Societa DiMutuo Soccorso Italiana of Dayton, Ohio and mails out congratulatory letters. Collects all dues timely and issues receipts. Transfers dues as collected to Treasurer with written "Statement of Account" indicating member(s) name, amount being transferred and method, i.e., cash or check.

Advises Council, reminds members at Assembly meetings and includes in monthly newsletter dues payable dates. Collects all dues within final due date of 60 days after January 1, yearly. Reports to Council any member(s) whose dues are not paid by said date. Makes every effort to collect dues – one individual phone call – then drops membership with reinstatement fee of \$15.00 payable to Societa DiMutuo Soccorso Italiana of Dayton, Ohio to reinstate after March 1. Verifies the monthly per capita statement from the Grand Lodge, noting any deletions or corrections to the Grand Lodge.

Treasurer

The Treasurer is the custodian of the funds of the Lodge. The Treasurer collects all monies (except dues) that come into the Lodge and deposits them in the financial institutions approved by the Lodge Council; gives a financial report at the meetings of all monies collected and paid out; pays the per capita tax and signs all checks with the counter

signature of the President. The Treasurer receives all bills of the Lodge and when properly approved, pays the bills. The Treasurer maintains accounting books of all income and expenditures and prepares financial reports in accordance with recognized accounting principles. The Treasurer furnishes a computerized record of the current year accounting and consults with the accountant in preparing and filing all tax returns. Computer accounting knowledge is a suggested requirement.

Trustees

(5 to be elected)

The Trustees examine and audit annually all the books kept by the Treasurer and ascertain that they are proper. They have the authority to audit books and financial records at any time. The Trustees will perform other duties as assigned by the President.

Masters/Mistresses of Ceremonies

(2 to be elected)

The Masters/Mistresses of Ceremonies participate in ceremonial activities prescribed by the laws of the Order during the course of the meeting. They formally present members into the Lodge at the initiation ceremony.

Guard

The Guard is the doorkeeper of the Lodge who admits only members into the meetings and excludes strangers. The Guard greets members at the membership meeting and is in charge of the sign-in register for membership meetings. After the membership meeting when new members have been introduced, the Guard then introduces the new members to the other members and makes them feel welcome.

Note: As stated prior, the non-required duties and responsibilities of all the above officers imposed by the John Pirelli Lodge may be reassigned as necessary by the President.

State Fraternal Delegate (Number elected to be decided based on number of members)

The State Fraternal Delegates represent the Lodge at the Grand Lodge state convention held every two years in the odd years. Conventions are held in June and usually are for three days at the end of the week. Each delegate is required to be present at all the meetings and functions. Any member, non-insured and insured, can be nominated and be elected as a State Fraternal Delegate.

Arbitration Commission

The first 5 to be elected are the "Commissioners" and the next 5 are the "Alternate Commissioners."

The Lodge Arbitration Commission consists of five members known collectively as "Commissioners" and five "Alternative Commissioners." The Arbitration Commission exercises the judiciary powers of the Local Lodge to enforce the laws of the Order, under Judicial Code of the Order, a separate document.

If a member has a dispute or claims that the laws are not being followed, the member can file a complaint with the Orator against the member. A complaint is heard by a single Trial Commissioner who solely hears the case and renders a decision. The Trial Commissioner is one of the five Commissioners and the decision is the law of the Order. The Recording Secretary serves as the Clerk of the Arbitration Commission.
